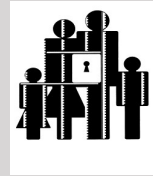

## From the Desk of the Directors

It only seems like yesterday that Judi and I assumed the roles as Directors of the Matthew 25 Center. From our guests coming and going, board meetings, group tours, the hosting of Kairos and Families in Crisis activities, and participation in the "In As Much Projects" by the Scotts Hill Baptist Church and the Burgaw Baptist Church, it indeed has been a very busy time.



The 2011 North Carolina General Assembly in its budget deliberations recommended the elimination of 25 of the 54 full time state-funded chaplain positions at low and medium security prisons. The House and Senate Appropriations committees approved this measure and, although the Governor vetoed the budget, the General Assembly overrode the Governor's veto. The budget language stipulated the current volunteer coordinator at each prison facility will assume the responsibility for the activities of all faith based volunteers alongside the many peripheral duties required of that position.

Without the presence of a full time trained clinical chaplain, many of the programs such as Kairos, Families in Crisis, and One Day with God will be in jeopardy. Sadly, too, the assurance of all ecumenical and inter-faith programs sorely needed by the residents of our prison system will also suffer.

The State of North Carolina dictates that when a state employee is to be eliminated, that person must be given a thirty day notice. With the anticipation of passing the proposed budget which would become effective July 1, 2011, it was decided in late May that 26 state-funded chaplains would be given their termination notice to be effective June 30, 2011. Unfortunately the state-funded chaplain's position at Pender Correctional Institution (PCI) was part of this process. The Community Resource Council at PCI which serves as the liaison between the local community and the prison is currently planning the solicitation of funds to contract for a community-funded chaplain in order to fill the void created by the actions of the General Assembly. As of this writing, Chaplain Joseph, a contract Chaplain, will remain in place at PCI for the time being. It is his hope that he will be able to remain at the PCI until the proposed chapel is completed.

As previously reported, the initial package for the proposed chapel at PCI was rejected by the State and was returned for suggested changes in the structural and architectural design. These issues have been resolved and we are now waiting the State's final stamp of approval. Through the efforts of the Community Resource Council, the necessary funds for the chapel have been solidified and the volunteer force organized by the North Carolina Baptist Men are eager to begin work. So, please continue with your prayers.

## Matthew 25 Happenings

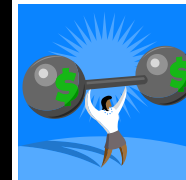
